Whether through achieving remarkable sales targets, driving substantial business growth, implementing transformative policies and procedures, or maintaining an unwavering commitment to customer service excellence, this award seeks to highlight and honour the healthcare and assistive technology retail companies that have truly stood out in the competitive marketplace.

We invite nominations from retailers of all sizes, recognising that excellence knows no bounds. This award serves as a platform for retailers to showcase their resilience, innovation, and dedication to providing exceptional products and services to their customers. Whether you are a well-established retail giant, an emerging player, or a family owned and run business, we encourage all eligible companies to participate and share their success stories.

Award criteria

This award is open to all types and sizes of retailer companies, but Entrants should have retail operations in the UK. Entrants should be able to provide specific examples, metrics, and data supporting their accomplishments over the last 12 months (July 2023 – June 2024).



Terms & conditions

By submitting the below form, you agree to abide by the following rules for the BHTA Industry Awards:

- All decisions of the independent and neutral Judging Panel are final and there is no right of appeal.
- BHTA and the Judging Panel are not obliged to make an award.
- The organisation submitting the entry must be a UK organisation (must be registered in the UK, Isle of Man, or Channel Islands).
- The ownership of the intellectual property must not be the subject of any dispute.
- BHTA retains the right to publicise all awards including winner, runner-up, and any commended entries, and all photographs taken on the evening to promote the award winners in whatsoever media it deem fit for the purpose.

Other information

- Any sensitive information that you DO NOT want to be shared MUST be designated as such in the entry eg. 'not for publication'. This includes exact budget figures etc.
- You must complete this entry form, in full, and return it with your completed submission. Incomplete entries or entries not received by the closing date will not be considered.
- Please return your submission as a word or .pdf document only.
- Entry submissions should be a maximum of 1000 words, in total. Entry submissions over 1000 words may not be considered by the judges. On top of your 1000-word entry you are asked to provide a 100-word company and a 100 word product description.
- You can apply for more than one award category, but you must complete an entry form for each category you enter and send them as two separate submissions.
- Only relevant supplementary information will be considered, which is in context with the submission. No marketing material should be used.

Please Note: Descriptions of submissions (other than commercially sensitive data previously notified) from winners and runner-ups may be used in publicity linked to the awards.

The deadline for nominations is 11 July 2024. All materials must be received by 5pm on the day to be considered. All applications should be made by organisations/individuals/companies involved in and supporting the ultimate care of society. Nominated entities must be working within the industry that BHTA supports.

 - Additional services that make the retailer stand out from competitors
 - Technological or sustainable innovations adopted by the retailer
 - Diversity & Inclusion policies

Supplementary evidence

You are able to submit additional supplementary evidence to support your submission. Supplementary evidence must be no longer than 2 pages of A4. Please submit your supplementary evidence along with your submission.

Supplementary evidence may include: case studies, original research, survey results, testimonials and info-graphics.

Our judges will also consider evidence that the retailer is pursuing professional development and is active in the industry, value added to the local community, and dedication to the key values of BHTA (---). The best entries will address these in their responses above.

Please also include:

- A high-resolution company logo
- A brief (100 words or less) description of the company, to be used in posts regarding nominations.
